Approve Agenda- Motion made by Steve Kenkel and second by Randy Hickey to approve the agenda. Motion passed unanimously.

Approve Chair and Vice Chair for Calendar Year 2020- Motion made by Frank Waters and second by Tony Smith to approve Richard Crouch as chair for calendar year 2020. Motion passed unanimously. Motion made by Randy Hickey and second by Frank Waters to approve Steve Kenkel as vice chair for calendar year 2020. Motion passed unanimously.

Approve December 2019 Meeting Minutes- Motion made by Chuck Morris and second by Tony Smith to approve the December 2019 meeting minutes. Motion passed unanimously.

Region Finance Information -

December 2019 Financial Reports- Motion made by Frank Waters and second by Marilyn Drake to approve the December 2019 financial reports as presented. Motion passed unanimously.

Per Capita Rate Recommendation for FY21- Suzanne Watson presented several options on the levy amount for FY21, with particular attention paid to the need to get to a 40% fund balance by FY22. The board discussed the pros and cons of a further decrease in the levy at this time to bring the fund balance down. The board decided to keep the levy the same for FY21 at \$25 per capita. Emphasis will be made on implementation of the necessary new services as a result of the children's legislation and HF2456. Motion made by Frank Waters and second by Mark Peterson to approve a \$25 per capita levy rate for fiscal year 2021. Motion passed unanimously.

Overview of Children's Implementation Plan due April 1, 2020- Suzanne Watson provided copies of the implementation template. The group reviewed the information therein and discussed beginning to put this information together over the next few months.

Discussion and Input About Upcoming Changes to 28E- The group discussed possible changes to the 28E due to implementation of the children's legislation. With the advisory board structure, the goal will be to have one Regional Advisory Board and separate public meetings. Currently, there are 2 tiers to the advisory structure, the local advisory councils and the region advisory board. The group also discussed the importance of getting representation on the advisory board from all member counties. Suzanne Watson asked board members to keep in mind individuals they think may be interested in being on the advisory board.

Region Staff Member Introduction- Molly Brown, Data Analyst- Molly explained her role and provided some samples of the data she generates as the region's data analyst. She provided information on the Hope 4 lowa call line and reviewed this with the board. In addition to her work within the region, Molly is also involved in several committees, including Quality Service Development and Assessment (QSDA), Justice Involved Services (JIS), Alternatives to Incarceration and the Data Analytics group with the ISAC Community Services Affiliate.

Region Service and Other Provider Updates: Lonnie Maguire provided an overview of service coordination statistics over the past month. There were 28 Service Coordination and 3 SOAR referrals in the month of December. Currently, the service coordinators are providing assistance to 350 clients. Lonnie reported MH Court has been busy as well. Danelle Bruce provided an update on Jail Service Coordination. In December, there were 18 referrals and 18 requests for service information. She also reported that a staff member from ISAC's Community Services Network (CSN) will be visiting the Pottawattamie County Jail tomorrow and will job shadow with the jail service coordinators to learn more about their role and data needs.

Update Calendar Year 2020 Board Meeting Schedule- Previously the board approved the meeting schedule, however on March 30, IWCC does not have an open room for the board meeting. The group agreed to change the March 30 meeting date to March 23rd.
