Approve Agenda- Motion made by Marilyn Drake and second by Chuck Morris to approve the agenda. Motion passed unanimously.

Approve February 2020 Meeting Minutes- Motion made by Steve Kenkel and second by Chuck Morris to approve the February 2020 meeting minutes. Motion passed unanimously.

Region Finance Information -

February 2020 Financial Reports- Motion made by Mark Peterson and second by Steve Kenkel to approve the February 2020 financial reports as presented. Motion passed unanimously.

Children's Implementation Plan- Suzanne Watson provided electronic copies of the implementation plan and the group reviewed the information. Motion made by Marilyn Drake and second by Tony Smith to approve the SWIA MHDS Region Children's Behavioral Health Services Implementation Plan. Motion passed unanimously.

FY21 Service and Budget Plan- Suzanne Watson provided electronic copies of the plan and the reviewed with the board. Expenditures amount for FY21 is \$8,542,688. Final revenues will be gathered from the Department of Management and put into the plan. Motion made by Randy Hickey and second by Steve Kenkel to approve the FY21 Annual Service and Budget Plan as presented, with addition of final revenue amounts once available. Motion passed unanimously.

SWIA MHDS Region 28E Agreement- Suzanne Watson provided electronic copies of the draft 28E document. The group reviewed requested language from last meeting regarding indicating that new voting members would not have voting authority on levy or budget matters. Suzanne suggested that due to the possible changes in state dollars coming into the regions, it may be

more prudent to limit voting only on levy matters. All board members in attendance agreed to limit new voting members on voting for levy matters only. Motion made by Marilyn Drake and second by Chuck Morris to approve the revised 28E of the SWIA MHDS Region, including language regarding voting capacity in sections 4.1 and 4.3. Motion passed unanimously. Suzanne will make changes and get copies to each member county auditor for approval at their county board meetings. The governing board will plan to have each county sign the revised document at the June 1, 2020 meeting.

Policy and Procedures Manual- Danelle Bruce reviewed changes to the Policy and Procedures Manual due to implementation of the children's behavioral health legislation, including changes to the governing board, advisory board, administrative team, eligibility, quality management and improvement, and the appendixes of the document. A draft outline was provided electronically. Motion was made by Marilyn Drake and second by Randy Hickey to approve the revised Policy and Procedures Manual. Motion passed unanimously.

Program Enhancement Grant for Outpatient Providers- Danelle Bruce reviewed the grant submissions with the board. An outline of submissions was provided electronically. Submissions included those from Burgess Mental Health, Heartland Family Service, CHI Psychiatric Associates, Southwest Iowa Mental Health Center, Myrtue Behavioral Health, and Waubonsie Mental Health Center. Danelle shared that after reviewing, leadership staff considered all requests to be within the scope of the grant except for the community education/marketing campaign submitted by Waubonsie Mental Health Center. Motion was made by Frank Waters and second by Marilyn Drake to approve \$7520 of the Waubonsie grant submission, with the ability to submit an additional grant request (up to the \$50,000 max amount) in the next 30 days. Motion passed unanimously, with Mark Peterson, Chuck Morris and Randy Hickey abstaining. Motion made by Frank Waters and second by Mark Peterson to approve the grant request of \$50,000 to Southwest Iowa Mental Health Center. Motion passed unanimously, with Chuck Morris abstaining. Motion made by Steve Kenkel and second by Marilyn Drake to approve the Burgess (\$49, 798.76), Heartland Family Service (\$50,000), CHI Psychiatric Associates (\$41,598.39), and Myrtue Behavioral Health (\$50,000) grant requests as submitted. Motion passed unanimously.

Legislative Updates- Suzanne Watson shared that legislation is at a standstill at the moment due to the shutdown related to COVID-19. She shared the governor visited the area recently and advocated for the property tax reduction.

Region Service and Other Provider Updates: Lonnie Maguire provided an overview of current measures to keep staff and clients safe due to the COVID-19 pandemic. Region staff who can work from home are being encouraged to with the exception of one administrative assistant in Shelby County and an administrative assistant, service coordinator, and CEO working from central office. The jail service coordinators continue to work from the Pottawattamie County Jail with revised procedures for working with clients.
