Approve Agenda- Suzanne Watson requested to add an action item to the agenda regarding approval of the Neapolitan Labs Website Development Proposal. Motion made by Tony Smith and second by Mark Peterson to approve the agenda with the additional action item. Motion passed unanimously.

Approve March 2020 Meeting Minutes- Motion made by Randy Hickey and second by Steve Kenkel to approve the March 2020 meeting minutes. Motion passed unanimously.

Region Finance Information –

March, April, May 2020 Financial Reports- Motion made by Chuck Morris and second by Marilyn Drake to approve the March, April and May 2020 financial reports as presented. Motion passed unanimously.

FY21 Proposed Provider Rates- Suzanne Watson provided a proposed rate sheet for FY21 and presented it to the board. Motion made by Steve Kenkel and second by Tony Smith to approve the FY21 provider rates as presented. Motion passed unanimously.

NAMI Southwest Iowa FY21 Funding Request- Suzanne Watson provided a handout of the request for funding by NAMI for FY21. Amount requested is \$12,000. Motion made by Tony Smith and second by Marilyn Drake to approve NAMI Southwest Iowa for \$12,000 in funding for FY21. Motion passed unanimously.

Waubonsie MHC Program Enhancement Grant- Waubonsie had previously been approved for a portion of the grant opportunity for FY20. Waubonsie provided an additional request to assist with repairs and remediation of their CSRS facility in the amount of \$42,480. Motion made by

Steve Kenkel and second by Frank Waters to approve Waubonsie MHC for the remaining grant availability dollars for FY20. Motion passed unanimously, with Mark Peterson, Randy Hickey, and Chuck Morris abstaining.

Sign SWIA MHDS Region 28E Agreement Between Counties- Suzanne Watson informed the board that all individual county boards of supervisors had approved of the signing of the amended region 28E. Members present in person at today's meeting signed the document, and Suzanne will get the remaining signatures needed this month from the other board members.

Adult MHDS Advisory Committee Appointments- Suzanne Watson provided the board with names of applicants interested in being on the Adult MHDS Advisory Committee. There was one change to the document provided in that Nicole Rocha wishes to resign her current committee assignment. Motion made by Tony Smith and second by Chuck Morris to approve the following individuals to the Adult MHDS Advisory Committee: Barb Belstene, Scott Halverson, Jessica Duncan, Jessica Johanns, Sherrie McDonald, Jamie Gross, and Chrissy Marsh. Motion passed unanimously. Suzanne will continue to seek an adult client/family member representative.

Children's Behavioral Health Advisory Committee Appointments- Suzanne Watson provided the board with names of applicants interested in being on the Children's Behavioral Health Advisory Committee. Motion made by Marilyn Drake and second by Chuck Morris to approve the following individuals to the Children's Behavioral Health Advisory Committee: Kathy Hanafan, Scott Halverson, Tarah Devlin-Lawler, Melissa Nation, Ryan McCormick, Ashley Harlow, and Debbie Orduna. Motion passed unanimously. Suzanne will continue to see out a law enforcement and parent representative for the children's committee.

Service Coordinator Hiring Plan- Lonnie Maguire informed the board that current service coordinator caseloads are averaging between 55-65 clients. Due to the implementation of children's services in July 2020, along with implementation of the Crisis Access Network by July 2021, region leadership would like the opportunity to hire 1-2 service coordinators once caseloads indicate a need to hire. Due to the majority of referrals coming from Pottawattamie County, Suzanne will ask permission from the Pottawattamie County Board of Supervisors to hire. The leadership team will keep the region governing board apprised of when hiring may take place during FY21.

Neapolitan Labs Website Development Proposal- Suzanne Watson reviewed the Neapolitan Labs website proposal with the board. The current region website platform is out of date and the region lacks technical support to assist as issues arise. Neapolitan will develop a mobile optimized, user-friendly website, to be powered by the Mint Chip Labs platform. Ongoing website hosting and support will also be provided. Motion made by Chuck Morris and second by Randy Hickey to approve the Neapolitan Labs Website Development Proposal in the amount of \$13,500, with an annual hosting and support cost beginning in July 1, 2021 of \$1,500. Motion passed unanimously.

Legislative Updates- The group discussed that the legislative session will reconvene on June 3, 2020. At this time there have been no other updates.

Region Service and Other Provider Updates: Lonnie Maguire reported that service coordination has continued to be busy in spite of the COVID-19 quarantine. There were 25 service coordination referrals in May and 5 SOAR referrals. Mental Health Court also continues to receive referrals. In addition, there has been an increase in requests from parents/guardians for client information related to retaining client eligibility for services/Medicaid programs. With Jail Service Coordination, Danelle Bruce reported the coordinators continue to work from their

home office due to COVID-19. They have been able to maintain communication with inmates using technology available at the Pottawattamie Jail, as well as by Zoom at other region jails. In May, staff worked with 18 clients. In addition, Danelle reported Al Hoffer has been named as new director at the HFS Bridge program.

COVID 19 Work Plans- Suzanne Watson reported that the Pottawattamie County campus will open up on June 8, 2020. Staff will be encouraged to utilize social distancing measures when meeting with clients and to continue to utilize phone and mail when possible. Gloves, hand sanitizer and masks are also available to staff. Staff will take their temperature before work and will stay home if they have symptoms. Other local courthouses in the region also continue to open up. Suzanne also reported that Sandy Fox, Administrative Assistant for the region, will be retiring July 31, 2020. An advertisement for her position will go out on June 5, 2020 on the Pottawattamie County website.
