**Select Chair and Vice Chair for calendar year 2021**- Motion was made by Tony Smith and second by John Hartkopf to accept Richard Crouch as the Chair. Motion passed unanimously. Motion was made by Randy Hickey and second by Tony Smith to accept Steve Kenkel as the Vice Chair. Motion passed unanimously.

**Approve December 2020 Meeting Minutes-** Motion made by Kathy Hanafan and second by Scott Belt to approve the December 2020 meeting minutes. Motion passed unanimously.

## Region Finance Information –

**December 2020 Financial Reports-** Motion made by Chuck Morris and second by Scott Belt to approve the December 2020 financial reports as presented. Motion passed unanimously.

**FY22 Per Capita Recommendation for SWIA MHDS Region County Budgets**- Motion made by Chuck Morris and second by Randy Hickey to approve \$23 per capita as presented. Motion passed unanimously.

Page County request to pay outstanding Case Management bill from Fund 10- Motion made by Scott Belt and second by Kathy Hanafan to approve Page County to pay outstanding case management bill of \$13,003.80 from Fund 10 after they complete a budget amendment. Motion passed unanimously with Chuck Morris abstaining.

**Legislative updates**-Suzanne Watson shared that she has been contacted by a legislator regarding Region's fund balance and other questions so there is discussion happening on the hill regarding regions and future funding possibilities through a 1 cent sales tax or other options. She also discussed IDPH and DHS merger and how this could impact the Regions.

**CARES ACT updates**-Suzanne Watson discussed the region has paid out \$1.78 million in CARES ACT grants to providers/school districts in our Region. We are one of few Regions that was able to spend all the money based on guidelines. The Region is required to submit a report to DHS breaking down the monies by provider and use. Suzanne has received several thank you notes/emails from providers/schools regarding the Region grants and the benefits it has made to their organization.

**Region Service and Other Provider Updates:** Lonnie Maguire reported that service coordination had 25 referrals in December 2020. This is similar to previous months. Lonnie reported that a new service coordinator was hired and started on Dec 28<sup>th</sup>. Lonnie also provided an update from Intake/Resource Referral for the Region.

**Open Discussion/Comment from Board Members**- Kathy Hanafan asked if the Region could request from those providers providing public education through the CARES ACT grants additional information regarding numbers of individuals that attend those trainings. Kathy also asked if the Region is involved in Unite Nebraska/Unite Iowa and requested Suzanne attend an upcoming meeting regarding this project. John Hartkopf stated that the merger between Zion and SWIA MHC is complete and going well.
