**Approve Agenda-** Motion made by Steve Kenkel and second by John Hartkopf to approve the agenda. Motion passed unanimously.

**Approve January 4, 2021 Meeting Minutes-** Motion made by Chuck Morris and second by Steve Kenkel to approve the January 2021 meeting minutes. Motion passed unanimously.

## **Region Finance Information -**

**January 2021 Financial Reports-** Motion made by Tony Smith and second by Steve Kenkel to approve the January 2021 financial reports as presented. Motion passed unanimously.

**Preliminary Budget Figures-** Suzanne Watson shared information about expenditures to date and that more information on specific budget figures will be given to the board during our next meeting, March 29<sup>th</sup>, which aligns with the due date for the Annual Service and Budget Plan approval from the board.

Legislative updates-Suzanne Watson shared that Region CEOs met with the Governor's office last week to discuss the \$15 million proposed by the Governor for this and next fiscal year. This is one-time money. The CEOs stressed they want to make sure it doesn't go toward levy reduction since it is not ongoing funding. There is also concern over increasing fund balances for those regions already trying to spend down balances. The group stressed equalization of

per capita rates across the state. There has also been discussion of extending the 40% fund balance requirement by moving it back a couple of years or getting rid of it. Rep. Dennis Bush may be introducing legislation pushing the 40% requirement back.

Brain Health Campaign – Suzanne Watson shared two Brain Health campaign videos. SWIA MHDS contributed \$10,000 toward this statewide campaign meant to educate about brain health and reduce stigma. Suzanne will send out the videos to board members to display on their county or provider websites as they see fit. Kathy Hanafan inquired about how the state AEA website and regions can coordinate in this effort as well. Suzanne will research and get back to Kathy.

Crisis Access Network (CAN) Update —Danelle Bruce and Lonnie Maguire updated the board on recent CAN planning meetings. The small group is meeting twice monthly to put into action final planning for the CAN to officially begin July 1. The group has begun a soft roll out of crisis service coordination for the CAN, with 3 referrals so far. Additional action includes coordinating with Central Iowa Juvenile Detention on transportation as well as further development of Peer Support for the CAN as well as Community Based Crisis Stabilization. Kathy asked about non LE crisis response in schools. Suzanne indicates they are in planning stages right now with more to come. John Hartkopf would like to know more about mobile crisis. Molly Brown from the region will be looking at data points for the CAN and how we can track to know we are developing services that people need and achieving desired outcomes.

Region Service and Other Provider Updates: Lonnie Maguire reported that service coordination in January had 22 referrals and 3 SOAR referrals. So far, there have been 3 CAN referrals and also some service coordination referrals for children through the CAN. Mental Health Court is working with 12 clients with 3 referrals pending. Jail Service Coordination in December had 23 referrals and in January 26 referrals. There were 25 Turnkey referrals in January. Suzanne Watson also shared that overall, 35% of crisis response referrals are for children.
