Approve Agenda- Motion made by Tony Smith and second by Mark Peterson to approve the agenda. Motion passed unanimously.

Approve August 2, 2021 Meeting Minutes- Motion made by Tony Smith and second by Mark Petersen to approve the August 2, 2021 meeting minutes. Motion passed unanimously.

Region Finance Information –

August 2021 Financial Reports- Motion made by Randy Hickey and second by Lynn Grobe to approve the August 2021 financial reports as presented. Motion passed unanimously.

Final FY20 Audit Report- Suzanne Watson shared the State Audit Report for the Region. Only one issue was stated in the report and that included that our region does not publishing governing board minutes in the newspaper. The Region is going to continue to publish these minutes on our Regional website as we feel this is more accessible to the public.

Approve new Advisory Committee Members- Lonnie Maguire shared the Region has received two advisory committee applications for 2 open positions, these individuals include Mary O'Neil (HFS Vice President) and Kate Smith (Therapist from Myrtue Behavioral Health). Motion made

by John Hartkopf and second by Mark Peterson to approve these two applicants for the Regional Advisory Committee as presented. Motion passed unanimously.

Decision on grant process for FY22 funding availability- Suzanne Watson shared a proposal for additional spending for existing line items that are needed for FY22. She also shared additional items for Competitive Grants proposal to be distributed in FY22. Suzanne recommended the Region work with a consultant to assist with the grant development and scoring. Motion made by Mark Petersen and second by Randy Hickey to approve the proposed increase in budget line items as well as the competitive grants and hiring of a consultant as presented. Motion passed unanimously.

Discussion draft policies for space and employment financing-Suzanne Watson presented these draft policies. The Board gave input on changes needed and additional items that need further investigation. Region Leadership will continue to work on these policies and bring back to the Board updated language with a goal of approval before County Budgets are due in Dec 2021.

Data and outcomes presentation: Molly Brown presented data and outcomes using deidentified client data from Regional Crisis Services. Molly showed the board how the Region can now drill down on this data to show what counties within the region are utilizing these services and what the outcome are for individuals utilizing services and other resources. Positive feedback was given by the Board regarding this presentation.

Region Service and other provider updates: Lonnie Maguire reported that Heartland Family Service has hired a team leader for Crisis Stabilization Community Based services. They continue to work on hiring additional staff needed for Rural ACT expansion and Crisis Stabilization Community Based services. Children's Square is working on hiring staff to provide Crisis Stabilization Residential Services for children. Maguire reported the jail service coordination program had 27 referrals in August and 24 jail kiosk requests for resources/information. Service coordination was extremely busy in the month of August. There were 40 service coordination referrals, 2 SOAR referrals and 17 CAN Crisis referrals in August. Intake/Referral had 26 calls for the month.

Open Discussion/Comment from Board Members- Suzanne Watson suggested the Governing Board may need to look at contracting with an attorney before FY23. She also mentioned a meeting that the Board may be interested in attending by zoom. ISAC is organizing this meeting between Department of Management and Board of Supervisors/CEOs to answer questions counties/regions may have regarding chart of accounts and payroll changes once Fund 10 is dissolved.
