**Approve Agenda-** Motion made by Steve Kenkel and second by Randy Hickey to approve the agenda. Motion passed unanimously.

**Approve February 28, 2022 Meeting Minutes-** Motion made by Randy Hickey and second by Tony Smith to approve the February 28, 2022 meeting minutes. Motion passed unanimously.

**Region Finance Information- February Financial Reports**- Motion made by Tony Smith and second by Steve Kenkel to approve the February 2022 financial reports. Motion passed unanimously.

**Approve FY23 Annual Service and Budget Plan-** Suzanne Watson provided an overview of the budget plan, including expenditures and revenues forecasted for the next fiscal year. Motion made by Chuck Morris and second by Randy Hickey to approve the FY23 Annual Service and Budget Plan. Motion passed unanimously.

**Discuss/Approve Final Grant Opportunities for FY22-** Suzanne provided an overview of additional grant ideas for the remainder of the fiscal year. These include grants in the areas of training for CMHC's and our CCBHC; curriculum and training for school districts; WRAP training; Psychiatric medication reimbursement to region jails; emergency department behavioral health improvements; repairs and infrastructure for region contracted providers and region ID

waiver/habilitation providers; and bedbug prep and treatment for individuals with mental health diagnoses. Motion made by Randy Hickey and second by John Hartkopf to approve the additional grant options, up to \$1,408,000. Motion passed unanimously.

Approve 28E Agreement Between SWIA MHDS Region and Pottawattamie County for fiscal agent/payroll, human resource, and internet technology services- Suzanne Watson reviewed the 28E with the board. Per this agreement, Pottawattamie County will be the employer of record for region employees. All human resource and IT needs will be billed to the region. Motion made by Tony Smith and second by Steve Kenkel to approve the 28E Agreement Between SWIA MHDS Region and Pottawattamie County for fiscal agent/payroll, human resource, and internet technology services. Motion passed unanimously.

Approve Lease Agreements Between SWIA MHDS Region and the counties of Montgomery, Page, Pottawattamie, and Shelby for County Property Occupancy-Suzanne Watson presented the lease agreement. An agreement will be made up for each county having office space for the region. Motion made by Steve Kenkel and second by Chuck Morris to approve the lease agreements between SWIA MHDS Region and the counties of Montgomery, Page, Pottawattamie, and Shelby for county property occupancy. Motion passed unanimously.

**Legislative Update-** Danelle Bruce provided a report of current legislation pertinent to the region, including SF 2195, SF 2216, and SF 2314.

Region Service and other provider updates: Lonnie Maguire and Danelle Bruce presented a new service update report to board members. Service coordination had 30 referrals (5 SOAR) in February. There were also 29 CAN referrals and 26 mental health court clients. Danelle Bruce reported the Jail Service Coordination program had 50 referrals in February, which includes individuals receiving mental health services in the jail as well as those identifying a mental health concern upon booking. For intake, the region received 107 calls in February, with at least 1 call coming from each member county. The region's promotional committee continues to meet, with plans to begin promotional interviews with KMA in April.

**Update on NAMI Southwest Iowa-** Anna Killpack provided the group with an overview of NAMI and our local chapter's efforts this fiscal year, including trainings and new hires. She reviewed budgetary concerns moving forward. Anna thanked the board for it's support of NAMI Southwest Iowa.
