Approve Agenda- Motion made by Tony Smith and second by Mark Peterson to approve the agenda. Motion passed unanimously.

Approve March 28, 2022 Meeting Minutes- Motion made by Steve Kenkel and second by Lynn Grobe to approve the March 28, 2022 meeting minutes. Motion passed unanimously.

Region Finance Information- March, April, May Financial Reports- Motion made by Mark Peterson and second by Randy Hickey to approve the March, April, and May 2022 financial reports. Motion passed unanimously. Suzanne Watson also provided an update on end of fiscal year budget projections. The regular budget (without state funds) ended at an estimated 31% fund balance. Estimated fund balance is \$6,268,000. Watson also indicated the initial state audit results for FY21 were positive with no major issues.

Approve FY23 Service Provider Contracts and Rates- Danelle Bruce provided an overview of proposed rate changes with providers for FY23. Most rates remained the same except for increases for mobile crisis, peer support with Waubonsie MHC, and Country Care RCF. Reimbursement for empty bed days has not been finalized yet with the CSRS/TLP programs in the region. Motion made by Chuck Morris and second by Mark Peterson to approve the FY23 service provider contracts and rates minus the CSRS/TLP programs. Motion passed

unanimously. Watson will come back to the board with finalized numbers on CSRS/TLP in the upcoming few months.

Designate Trivium Life Services IRS Home- Suzanne Watson provided an overview of the IRS home model and supporting documents showing Trivium has met the requirements of an IRS as set forth by the Iowa Department of Human Services. The first 4-bed home will be located in Sioux City, Iowa, with a projected start date of August 1, 2022. Motion made by Tony Smith and second by Steve Kenkel to designate Trivium Life Services as per the requirements set forth. Motion passed unanimously.

Approve Intensive Residential Service Home Service Start-up Costs- Suzanne Watson reviewed the start-up costs for the IRS home with Trivium Life Services. Costs are being shared with the Rolling Hills region. Motion made by Mark Peterson and second by Randy Hickey to approve start-up cost funding in the amount of \$36,018.25 for the IRS home with Trivium Life Services. Motion passed unanimously.

Website Privacy, Legal and Linking Policy- Lonnie Maguire reviewed a new policy pertaining to the region's website and needed protections from liability for content therein. The policy is mirrored off the Pottawattamie County website policy. Motion made by Chuck Morris and second by John Hartkopf to approve the Website Privacy, Legal and Linking Policy. Motion passed unanimously.

Legislative Update- Danelle Bruce reported the legislative session ended late, with few bills passed pertaining to mental health and the regions. The proposal of regions being able to retain a 10% fund balance in FY24 vs. a 5% fund balance did not pass. The Legislative Review Committee of the Iowa Community Services Affiliate will make this a priority for next legislative session, along with changes needed in Iowa Code 229 as they relate to mental health advocates, confidentiality laws, and rules changes regarding region requirements for Evidence Based Practices.

Region Promotion Videos- Lonnie Maguire and Danelle Bruce shared a few of the informational videos produced by KMA. There are 9 videos in all highlighting different aspects of the region, such as children's service coordination, crisis services, jail service coordination, and others. The videos will be put on the region's website as well as the KMA website. In addition, videos may be distributed to schools, providers, and others to market the region.

Psychiatric Medication Reimbursement in Jails- Danelle Bruce shared that most jails in our region have submitted for reimbursement of psychiatric medications for at least some of FY22. Three jails have not submitted yet, which are Mills, Fremont, and Cass County Jails. Bruce encouraged that each jail can still submit for FY22. Regarding approving medication reimbursement for FY23, the Board will table this item until final reimbursements are made for this fiscal year. This will be readdressed in August.

Region Service and Other Provider Updates: Lonnie Maguire and Danelle Bruce presented the service update report to board members. Service coordination had 32 referrals (3 SOAR) in May. There were also 29 CAN referrals and 26 mental health court clients. Danelle Bruce reported the Jail Service Coordination program had 23 referrals in May. For intake, the region received 98 calls in May, with at least 1 call coming from each member county. Other updates include that a new Veterans Treatment Court is beginning soon in the 4th Judicial District. CIT training (sponsored by the region) will take place July 11-15 and August 1-5. Also, Harbor Point CSRS has been staying full in the past few months.

Supporting the Mental Health of Healthcare Teams- Suzanne Watson shared that a small group is working on developing a curriculum of support/treatment for medical professionals

impacted negatively by the COVID-19 pandemic. Sierra Warden of University of Nebraska at Omaha is developing the curriculum, which would be provided by mental health professionals. At some point there could be a request for financial assistance from the region to support costs of providing the program to our local hospitals.

Open Discussion/Comment from Board Members- Tony Smith inquired if mobile crisis assesses children. Suzanne Watson indicated that yes, the team does see children.
