 - Myrtue: a wait list, offering some group options. They are scheduled 3-5 months out with medication management closer to one month out.
 - SW IA Families: scheduled out 6-8 months. They have 8 therapists but only a few are full time.
 - Heartland Family Service: continue to do walk-in hours but some individuals have been turned away due to workforce issues and the need to prioritize specific groups ie pregnant women. They currently have six therapist openings at the main office location.
