**Approve Agenda-** Motion made by Mark Peterson and seconded by Bernard Pettinger to approve the agenda. Motion passed unanimously.

**Approve January 30, 2023, Meeting Minutes-** Motion made by Steve Kenkel and seconded by Tony Smith to approve the January 30, 2023, meeting minutes. Motion passed unanimously.

**Region Finance Information- January and February 2023 Financial Reports**- Motion made by Judy Clark and seconded by Tony Smith to approve the January and February 2023 financial reports. Motion passed unanimously.

**Approve End of FY23 Expenditures Framework-** Suzanne Watson reviewed with the board a framework for additional one-time assistance to providers that would be expended prior to the end of the fiscal year. Motion made by Tony Smith and seconded by Steve Kenkel to approve the end of FY23 expenditures framework. Motion passed unanimously.

**Approve FY24 Service and Budget Plan-** The Leadership Team reviewed the draft plan with the board, including the proposed budget for FY24. Motion made by Steve Kenkel and seconded by Bernard Pettinger to approve the FY24 Service and Budget Plan. Motion passed unanimously.

**Approve Letter to Pottawattamie County Board of Supervisors for CEO FY24 Salary**- Suzanne Watson presented a letter honoring the final decision of the Pottawattamie County Board of Supervisors in its standard compensation increases for appointed Director salaries for FY24. The CEO FY24 salary increase percentage would match other Pottawattamie County department

heads. Motion made by Tony Smith and seconded by Mark Peterson to approve. Motion passed unanimously.

**Review Draft of HHS Performance Based Contract**- Suzanne Watson reviewed a draft copy of the proposed HHS/Region FY24 performance-based contract. She indicated the CEOs and HHS will meet next week to discuss any further changes.

**Legislative Update**- Danelle Bruce reported on HF471/SF471 bills as they relate to the regions. HF471 passed out of the House and SF471 is still being debated. The legislation moves all region related Iowa code references from county (331) to HHS (225C). It also changes the governance structure of regions to include that no more than 49% of the board may be made up of County Boards of Supervisors. It also adds a member in the judicial system to the board as well as a law enforcement member. The bills also make community-based competency restoration a core service for regions. Suzanne Watson reviewed the state government realignment legislation as it relates to HHS. There will be a Division of Behavioral Health encompassing mental health and substance use services as well as a division encompassing the Department of Aging and Disability Services.

**Governing Board Structure/Impact Discussion**- Steve Kenkel suggested board members consider over the next few months whether they wish to remain on the governing board should HF471/SF471 legislation pass (which is expected). With the current makeup, the board would move to having 6 County Boards of Supervisors, along with an additional law enforcement and judicial member.

**Region Services and Other Provider Updates**-Lonnie Maguire presented the service update report to board members. Service coordination had 44 referrals (3 SOAR) in February. There were also 34 CAN referrals and 13 mental health court clients. The Jail Service Coordination program had 23 referrals in February. For intake, the region received 113 calls in February. In addition, the region will have a staff training retreat in May 2023, focusing on stress reduction.
