Approve Agenda- Motion made by Steve Kenkel and seconded by Bernard Pettinger to approve the agenda. Motion passed unanimously.

Approve March 27, 2023, Meeting Minutes- Motion made by Tony Smith and seconded by Steve Kenkel to approve the March 27, 2023, meeting minutes. Motion passed unanimously.

Region Finance Information- March, April, and May 2023 Financial Reports- Motion made by Mark Peterson and seconded by Judy Clark to approve the March, April and May 2023 financial reports. Motion passed unanimously.

Review End of FY23 Expenditures- Suzanne Watson provided an update on end of year expenditures and reported the region met the 20% fund balance target. She highlighted various additional one-time assistance grants to providers, who were very appreciative of the assistance given.

Approve FY24 Provider Rates/Contracts- Danelle Bruce reviewed proposed rates for region providers for FY24, noting the 3-year contract is due this fiscal year. A rate sheet was presented noting any changes. Motion made by Judy Clark and seconded by Steve Kenkel to approve the proposed FY24 provider rates. Motion passed unanimously.

Acknowledge Email Approved Vote to Sign Amended Performance Based Contract with HHS-Danelle Bruce reminded the board they previously approved the FY24 contract per an email vote, and requested the board officially approve the F24 Performance Based Contract with an

in-person vote. Motion made by Tony Smith and seconded by Kathy Hanafan to approve the Amended Performance Based Contract with HHS. Motion passed unanimously.

Governing Board Structure/Impact Discussion- Suzanne Watson shared a document leadership developed offering suggestions for governing board structure moving forward. Consensus was that members should have a 3-year term, and that members must go off the board for a period of one year before reapplying. Board members present today offering to continue to serve were Steve Kenkel, Tony Smith, Bernard Pettinger, Mark Peterson, Richard Crouch, Kathy Hanafan, Scott Halverson, and Mary O'Neill. Berneeta Wagoner, who was not present today, had previously indicated her continued interest. Leadership will contact Allison Leach to as her intent to continue. The group also determined a member from the county employer of record and fiscal agent should be on the board (from Pottawattamie County). The group discussed an application process that will be developed for all board members after this initial appointment and will research possible law enforcement and judicial members over the next two months, with the goal of persons interested attending the August meeting and being officially approved.

Approve SWIA MHDS Region 28E Changes- Suzanne Watson reviewed proposed changes to the 28E based on HF471 and discussion on governance today. Motion made by Bernard Pettinger and seconded by Judy Clark to approve the amended 28E. Motion passed unanimously. The board chair and secretary will sign the finalized document in front of a notary and copies will be dispersed to the member counties.

Region Services and Other Provider Updates-Danelle Bruce presented the service update report to board members. Service coordination had 30 referrals in April (5 SOAR) and 50 referrals in May (2 SOAR). There were also 36 CAN referrals in April and 9 mental health court clients. In May, there were 37 CAN referrals and 10 mental health court clients. The Jail Service Coordination program had 25 referrals in April and 41 in May. For intake, the region received 117 calls in April and 141 in May. In addition, Bruce reported that Zion/Harbor Point CSRS paused admissions for the month of June due to staff shortages. They plan to reopen on July 5th. The new Individual Placement and Supports (IPS) supported employment program began on June 15th and they have 2 referrals so far. In addition, Bruce handed out a Crisis Intervention Training (CIT) flyer to the group as the region will host its 4th training September 11-15th. This training is for law enforcement and first responders. Suzanne Watson also shared the state is doing a study to review all the programs under HHS, with recommendations to come in September. Also, leadership will soon revise the region's policy and procedure manual and will bring updates to the August meeting.
