**Approve Agenda-** Motion made by Steve Kenkel and seconded by Mark Peterson to approve the agenda. Motion passed unanimously.

**Approve August 28, 2023, Meeting Minutes**- Motion made by Steve Kenkel and seconded by Tony Smith to approve the August 28, 2023, meeting minutes. Motion passed unanimously.

**Region Finance Information- August, September, and October 2023 Financial Reports-** Motion made by Mark Peterson and seconded by Kathy Hanafan to approve the August, September, and October 2023 financial reports. Motion passed unanimously.

**Approve FY23 Annual Report**- Watson, Maguire, and Bruce reviewed the FY23 Annual Report with the board. Motion made by Steve Kenkel and seconded by Tony Smith to approve the FY23 Annual Report as presented. Motion passed unanimously.

**Approve June 30, 2023, Fund Balance Certification**- Watson presented a document indicating the June 30, 2023, Fund Balance Certification. Motion made by Mary O'Neill and seconded by Mark Peterson to approve the board chair to sign off on the certification form. Motion passed unanimously.

Approve Request to Support the Grow with Green Hills June 2024 Conference- Kathy Hanafan informed the group that the AEA will be sponsoring a 3-day conference in June 2024 at the Mid-America Center in Council Bluffs, with a focus on school safety. National speakers will be brought in as well as local experts with a focus on behavioral threat assessment, suicide risk assessment, and social-emotional learning related to prevention of acts of violence toward self and others. The AEA requests sponsorship from the region for this event in any amount the

board deems appropriate. Motion made by Tim Wichman and seconded by Tony Smith to approve \$10,000 in sponsorship of the 2024 Grow with Green Hills conference. Motion passed unanimously, with Hanafan abstaining.

Preliminary Funding Approval for CHI/Children's Square Children's Center of Excellence for Behavioral Health- Watson shared that a small group made up of CHI staff, Children's Square staff, Region, and BWBR Architectural firm, have been meeting to discuss and potentially plan for a children's center for excellence in behavioral health at the Children's Square campus in Council Bluffs. Examples of services at the center include inpatient hospitalization, partial hospitalization, crisis stabilization residential services, and an assessment center. Suzanne requested the board's support of continued planning for this center in the upcoming months. Later, the region may be asked to make a financial investment. Discussion was had regarding Jennie Edmundson's planned expansion in behavioral health with the addition of a new inpatient unit to include children's beds. Motion made by Steve Kenkel and seconded by Tim Wichman to approve the region's participation in the planning process for the proposed children's center for excellence in behavioral health at the Children's Square campus. Motion passed unanimously, with Halverson abstaining.

Approve Board Meeting Dates for Calendar Year 2024- Watson presented a document with proposed dates for 2024 meetings of the board. One was the same schedule as for the past year, and the other included the group meeting every other month. Motion made by Mary O'Neill and seconded by Bernie Waggoner to approve the board meeting every other month in 2024. Meeting dates to include January 29, March 25, June 3 (May meeting), July 29, September 30, and November 25. Motion passed unanimously.

**Region Services and Other Provider Updates**- Watson referred to the service update in the board packet for region service coordination, Jail service coordination, SOAR, Mental Health Court, and Intake/Referral. No other updates given.
