Approve Agenda- Suzanne Watson requested the agenda be amended to discussion only of the Performance Based Contract with HHS as the contract is not out yet. Motion made by Bernard Pettinger and seconded by Mark Peterson to approve the amended agenda. Motion passed unanimously.

Approve March 25, 2024, Meeting Minutes- Motion made by Steve Kenkel and seconded by Tony Smith to approve the March 25, 2024, meeting minutes. Motion passed unanimously.

Region Finance Information- Approve March, April, and May 2024 Financial Reports- Motion made by Tony Smith and seconded by Kathy Hanafan to approve the March, April, and May 2024 financial reports. Motion passed unanimously.

Ending FY24 Budget Projection- Suzanne Watson shared that a few small training projects were approved with Waubonsie Mental Health Center/Southwest Iowa Families for Autism training, as well as Solution Point+ for X-Factor law enforcement training. Payroll expenses to Pottawattamie County will also be submitted prior to end of the fiscal year. Expenditures for June are targeted at \$1.3 million. She does expect the region to get under the 5% fund balance target to get all funds in FY25.

Update on FY25 Budget- Suzanne Watson shared that the budget will be tight in FY25 and she will watch it very closely. There are some variables that may affect the budget in the new fiscal year, such as if Heartland Family Service (HFS) gets a CCBHC grant and would thus be able to bill CCBHC for some crisis services the region currently funds.

Approve FY25 Service Provider Contract Rates- Danelle Bruce shared with the board a rate reference sheet of proposed rates for FY25. Most rates will remain the same or at the current Medicaid rate except for additional funds for start up for IPS with both Vodec and Heartland Family Service. In addition, Heartland's crisis services costs have overall gone down, but the region will be setting some targets on certain services, such as Rural ACT, to bring in more Medicaid funds and thus less region funds into the overall cost. Motion made by Kathy Hanafan and seconded by Tony Smith to approve the rate sheet as presented. Motion passed unanimously.

Discuss Performance Based Contract with Iowa HHS- Suzanne Watson shared that the new contract is not out yet but gave an overview of what region CEO's have verbally been told will be in the FY25 contract. There will be code reference changes, removal of Justice Involved Services references, removal of tracking of prevention/early education activities within the region, removal of service coordination study efforts, and removal of the HHS study to approve administrative costs for the regions. There will be language added regarding the administrative service organizations and regions cooperating with HHS during this transition period. Regions will continue to provide care coordination. Suzanne will contact the Board once the contract is sent to request approval.

Update/Approve Plan for Service Coordinator- Open Position- Lonnie Maguire shared that one of the region's service coordinators left employment on May 17,2024. This has resulted in additional workload for the remaining service coordinators. Due to the wind-down of regions over the next year and uncertainty, region leadership does not feel it's appropriate to hire another full-time staff. Instead, leadership are requesting to begin advertising for a full-time temporary Service Coordinator Intern position to assist staff with duties. Motion made by Steve Kenkel and seconded by Mark Peterson to approve the advertisement and hiring of a temporary full-time intern. Motion passed unanimously.

Update on Children's Square Crisis Stabilization Programs- Lonnie Maguire shared that Children's Square opened their residential 6 bed crisis stabilization residential program on May 20th. They haven't had an admission yet but have a house on campus that is being used. Children's Square also continues to operate a community-based Crisis Stabilization program (Anywhere Care) for children as well.

Planning for HHS Realignment Legislation and Timeframe- Suzanne Watson shared a presentation that was sent out by HHS regarding the realignment and timeframes. This was reviewed as a group. The map for the new Behavioral Health Districts will be out by August 1st. There will be town halls and listening sessions prior to that for the community to provide feedback on the possible maps and plan moving forward.

Region Services and Other Provider Updates- Lonnie Maguire presented data in graph presentation for the Region's central intake, service coordination, crisis service coordination and resources and referrals calls through April 2024. Danelle Bruce shared that X-Factor training for law enforcement will take place in Council Bluffs June 10-11, and June 12-13, and we are still seeking additional law enforcement personnel to register. Suzanne Watson shared that she attended resource fairs in Pottawattamie and Shelby counties after the recent tornados. No other updates given.

Open Discussion/Comment from Board Members- Bernie Waggoner shared that SWIA Families, along with Waubonsie Mental Health Center, will bring an Autism training to Clarinda on June 24th. She thanked the region for it's support financially to bring this training to Southwest Iowa.
